

## **Metropolitan Center** for Independent Living

Important new regulations under a federal law called the Workforce Innovation Opportunity Act (WIOA) require that individuals who are paid less than the minimum wage be offered a meaningful opportunity at least once a year to learn about the services and supports available to assist them in securing competitive, integrated employment. The Metropolitan Center for Independent Living (MCIL) has scheduled informational meetings to learn more about the WIOA Career Counseling, Information, and Referral Process, and to complete the required form.

These meetings will be held during the scheduled times listed below. MCIL staff will give a brief presentation, explain how WIOA affects you, and answer any questions you have regarding employment in the community. MCIL staff will then assist with the completion of a Career Counseling, Information, and Referral Documentation form. This conversation is designed to help you make an informed choice about whether or not to pursue competitive, integrated employment. There is no need to RSVP for these meetings. MCIL will be scheduling more meetings in the coming months at both community and provider sites if you cannot attend the meetings listed below.
